



“Azzardo in the Land of Lemurs” COMPETITION RULES

§ 1. GENERAL PROVISIONS

1. These Rules (hereinafter referred to as the “**Rules**”) define the principles, scope and conditions for participation in the “**Azzardo in the Land of Lemurs**” competition (hereinafter referred to as the “**Competition**”).
2. The organiser of the Competition is Azzardo Sp. z o.o. with its registered office in Poznań, ul. Strzeszyńska 33, 60-479 Poznań, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court Poznań Wilda and Jeżyce in Poznań, 8th Commercial Division of the National Court Register, under KRS no: 0000487708, holding the National Business Registry Number (Regon): 081176240 and Tax Identification Number (NIP) 9291857507 (hereinafter referred to as the “**Organiser**” or “**Azzardo**”).
3. The Competition is financed by the Organiser's own funds.

§ 2. ADDRESSES OF THE COMPETITION

1. The “**Azzardo in the Land of Lemurs**” Competition is organised on the occasion of the 15th anniversary of the distribution of Azzardo lighting products and is addressed to business entities, regardless of the organisational and legal form of their business, which cooperate with Azzardo in the distribution of Azzardo lighting products.
2. Participants in the Competition may be business entities, regardless of the organisational and legal form of their business, i.e. natural persons conducting business, legal persons and business entities without legal personality, who (i) have cooperated with Azzardo in the period from 1 April 2024 in the distribution of Azzardo lighting products and (ii) have their registered office in the territory of Europe (hereinafter referred to as “**Distributors**”).

§ 3. DURATION OF THE COMPETITION

1. The Competition lasts from 1 April 2026 00:00:01 to 30 November 2027 23:59:59 inclusive.
2. The Winners will be selected on the fastest possible date after the end of the Competition. The exact date and venue for the selection of the Winners will be communicated to the Participants by the Organiser no later than 14 days prior to the date of the Prize Drawing.

§ 4. PRIZES

1. Each Participant who takes part in the Competition has the opportunity to win the right to a two-person Voucher entitling to a **one-week stay in luxurious hotel in Madagascar**, which will include transfer from an indicated place in Poland to the destination place, accommodation in a room for two people in an *all-inclusive* formula, transfer from the destination place to the place of departure in Poland (hereinafter referred to as the “**Trip**”).
2. The detailed organisation of the Trip is the responsibility of the Organiser. As part of the

organisation of the Trip, the Organiser determines the journey, selects the hotel, distributes the Winners among the hotel rooms and makes all other organisational decisions regarding the execution of the Prize.

3. The Trip is scheduled to take place in the first half of 2028. The exact date of the Trip will be communicated to the Participants by the Organiser no later than on the day of the Prize Drawing.
4. Each Participant of the Competition is entitled to receive only one Prize, irrespective of the number of Draws taking part in the Prize Drawing.
5. The condition of receiving the Prize is not having any overdue liabilities to the Organiser on the date of selecting the Winners.

§ 5. PARTICIPATION IN THE COMPETITION

1. Distributors who wish to participate in the Competition are required to register via the registration form available at <https://www.en.azzardo.com/competition> no later than on 30th April 2026 at 23:59:59.
2. Participation in the Competition is voluntary.
3. In order to enter the Competition, the Distributor must accept the Competition Rules and provide data indicated in the registration process.
4. By registering for the Competition, the registered Distributor becomes a Participant of the Competition.

§ 6. OBTAINING RIGHT TO THE PRIZE

1. The prize in the "Azzardo in the Land of Lemurs" Competition is the opportunity for the Distributor to purchase a two-person Voucher entitling to the Trip, i.e. to a **one-week stay in luxurious hotel in Madagascar**, for a net amount of EUR 1.00 (one EUR), which will include transfer from a designated location in Poland to the destination place, accommodation in a room for two persons on an *all-inclusive* basis, transfer from the destination place to the starting point in Poland (the "**Prize**").
2. Basic terms:
 - a. The Base Period is the period from 1 April 2024 to 30 November 2025 (20 months).
 - b. The Competition Period is the period from 1 April 2026 to 30 November 2027 (20 months).
 - c. Average Monthly Net Turnover in the Base Period is understood as the total net Turnover of the Distributor made with Azzardo on Azzardo lighting products in the period from 1 April 2024 to 30 November 2025 divided by the number of calendar months in which the Turnover was made, which means that the number of months does not include those calendar months in which the Distributor's net Turnover made with Azzardo on Azzardo lighting products was EUR 0.00 (zero EUR).
 - d. Average Monthly Net Turnover during the Competition Period is understood as the total Distributor's total Net Turnover made with Azzardo on Azzardo lighting products in the period from 1 April 2026 to 30 November 2027 divided by the number of calendar months of the Competition, i.e. 20 (twenty).
3. Each Competition Participant who (i) makes an Average Monthly Net Turnover during the Competition Period which is higher than the Average Monthly Net Turnover during the Base Period by more than EUR 900 (nine hundred EUR) net and at the same time (ii) whose total Turnover during the Competition Period is at least EUR 36.000,00 (thirty six thousand EUR) net, will be entitled to purchase a two-person Voucher without participating in the Prize Drawing ("**Guaranteed Prize**").
4. Each Competition Participant who (i) makes an Average Monthly Net Turnover during the

Competition Period of at least the same level as the Average Monthly Net Turnover during the Base Period and at the same time (ii) whose total Turnover during the Competition Period amounts to at least EUR 18.000,00 (eighteen thousand EUR) net, will receive one Draw which will participate in the Prize Drawing, i.e. the right to purchase one of three two-person Trip Vouchers.

5. The Organiser guarantees that the number of Guaranteed Prizes is unlimited, the number of Prizes to be drawn is 3 (three).
6. The Winners, i.e. those entitled to purchase the two-person Voucher, will be selected by means of a prize draw.
7. Each Competition Participant is entitled to purchase only one two-person Voucher regardless of the number of Participant's Draws.
8. Each Participant who fulfils the conditions of the Competition specified below is entitled to receive Draws in the number and on the terms specified below.
9. In the event that a Participant of the Competition makes a Net Average Monthly Turnover during the Competition Period higher than the Net Average Monthly Turnover during the Base Period by more than:
 - e. EUR 90.00 (ninety EUR) net, it will be entitled to receive an additional Draw entitling to participate in the Prize Drawing,
 - f. EUR 180.00 (one hundred eighty EUR) net, it will be entitled to receive an additional two Draws entitling to participate in the Prize Drawing,
 - g. EUR 270.00 (two hundred seventy EUR) net, it will be entitled to receive an additional three Draws entitling to participate in the Prize Drawing,
 - h. etc., until it reaches the right to receive the Guaranteed Prize.
10. A Competition Participant who becomes entitled to the Guaranteed Prize does not take part in the Prize Drawing.
11. Notwithstanding the above, in any event, a Participant who has overdue obligations to Azzardo will not be entitled to receive the Prize, the Guaranteed Prize and the use of the Voucher, and the persons designated by it will not be entitled to participate in the Trip.

§ 7. PRIZE DRAWING

1. All Draws obtained by the Participants take part in the Prize Drawing.
2. The Prize Drawing will take place at a gala event in such a manner as to ensure that the Winners are selected at random.
3. The Winner is the Competition Participant whose Draw is drawn by means of the Prize Drawing.
4. Each Participant is entitled to purchase only one two-person Voucher regardless of the number of Draws they have, which means that if two or more Draws are drawn for the same Participant, it is entitled to purchase only one two-person Voucher.
5. In the event of drawing a Draw of a Participant who has acquired the right to the Guaranteed Prize or whose Draw has already been drawn earlier, the Committee will proceed to a new prize drawing.
6. The Voucher or the right to purchase the Voucher cannot be sold or transferred under any title to a third party, including to another Participant.
7. The Voucher is not exchangeable for its monetary equivalent.

§ 8. COMPLAINTS

1. The Competition Committee, appointed by the Organiser and consisting of at least three persons, supervise the correct course of the Competition and the selection of the Winners, including the conducting of the Prize Drawing in a manner ensuring secrecy.

2. The composition of the Competition Committee will be determined by the Organiser and communicated to the Participants.
3. All reservations, remarks and complaints should be submitted to the Competition Committee immediately by e-mail to konkurs@azzardo.com ("*Complaints*").
4. Each member of the Competition Committee is entitled to consider the Complaint individually.
5. The Participant is entitled to file an appeal against the decision of a Competition Committee Member to the entire Competition Committee, which then decides collectively by a simple majority of votes.
6. The Collegial decision of the Competition Committee is final and binding. The Organiser does not foresee an additional appeal procedure against the Collegial guzikdecision of the Competition Committee.

§ 9. PRIZE COLLECTION


1. The announcement of the Winners of the Competition and the Participants entitled to the Guaranteed Prize will take place immediately after the Prize Drawing, during the ceremonial gala.
2. Notwithstanding the public announcement, the Winners and those entitled to the Guaranteed Prize will be informed of the award of the Prize by e-mail correspondence to the e-mail address provided during the registration process.
3. Within 14 days from the date of the Prize Drawing, the Winners and those entitled to the Guaranteed Prize are obliged to:
 - a. submit a declaration of wish to purchase the Voucher to the Organiser,
 - b. submit personal details of persons who will make use of the Voucher, i.e. take part in the Trip, to the Organiser, however with the provision that at least one of the persons indicated must be an adult owner, partner, board member or employee of the Winner.
4. Provision of personal data is binding for the Participant. The Organiser stipulates that a subsequent change of the person who will take part in the Trip is not possible.
5. The participation of the person indicated by the Winner on the Trip is conditional for the provision of all data necessary to make the relevant bookings, purchase tickets, check-in etc., by the date indicated by the Organiser.
6. The Organiser points out that the Voucher does not include insurance of persons and property during the Trip once on the way to and from the Trip.
7. After submitting a statement of intent to purchase the Voucher to the Organiser, Azzardo will issue a VAT sales invoice for EUR 1.00 (one EUR) net to the Participant and send it to the Participant in electronic form to the e-mail address provided by the Participant during registration.
8. Failure to submit a statement of intent to purchase the Voucher, failure to provide the Organiser with personal details of the persons who will use the Voucher or failure to provide the Organiser with the details necessary to make the relevant bookings etc. within the time limit specified by the Organiser will result in the Participant losing the right to take part in the Trip without the right to claim compensation.

§ 10. FINAL PROVISIONS

1. The Participant may be removed by the Organiser from the list of Participants at any time in the event of:
 - a. having overdue liabilities towards the Organiser,
 - b. acting to the detriment of the Organiser or any company from the Organiser's capital group (capital-related company),
 - c. failure to comply with the terms and conditions specified in these Rules,

- d. indicating as participants of the Trip persons who do not fulfil the requirements specified in the Rules.
2. The controller of the personal data of the Participants and persons designated by the Participants to take part in the Trip is Azzardo Sp. z o.o. with its registered office in Poznań at ul. Strzeszyńska 33, 60-479 Poznań. Personal data will be processed for the purpose of the Competition and the Trip. The Participants have the right to inspect their data in order to correct them, if necessary, and to request their deletion. Provision of data is voluntary, however it is necessary to participate in the Competition. Detailed rules for the processing of personal data of the Participants and persons designated by the Participants are set out in a separate document – the Privacy Policy.
3. The Organiser reserves the right to change these Rules, provided that such a change will not violate the already acquired rights of the Participants. The Organiser will inform the Participants of any change to the Rules by e-mail correspondence to the email address specified in the course of registration.
4. In all matters not regulated by these Rules, the provisions of the Polish law, in particular the Civil Code, apply.
5. All disputes relating to the Competition will be resolved by a competent Court having its jurisdiction over the registered office of the Competition Organiser.
